2. (U) PURPOSE: POLICY CLARIFICATION.

2.A. (U) IMMUNIZATION REQUIREMENTS WILL BE IMPLEMENTED IN ACCORDANCE WITH REFERENCE 1.A.

2.B. (U) IN THE EVENT OF A DECLARATION OF A MEASLES OUTBREAK ON AN INSTALLATION, APPROPRIATED AND NONAPPROPRIATED EMPLOYEES, AS WELL AS FAMILY CHILD CARE PROVIDERS, LOCAL NATIONAL PERSONNEL, SPECIFIED VOLUNTEERS, AND CONTRACTORS WHO ARE NOT IMMUNIZED, WILL BE EXCLUDED FROM THE PROGRAM FOR THEIR HEALTH PROTECTION AND THE PROTECTION OF THE HEALTH OF OTHER CHILDREN, STAFF, AND VOLUNTEERS UNTIL THE COMMUNICABLE PERIOD OF THE OUTBREAK IS OVER.

2.C. (U) DURING A DECLARED OUTBREAK OF MEASLES, IF APPROPRIATED AND NONAPPROPRIATED EMPLOYEES, AS WELL AS FAMILY CHILDCARE PROVIDERS, LOCAL NATIONAL PERSONNEL, SPECIFIED VOLUNTEERS, OR CONTRACTORS, CHOOSE TO OBTAIN IMMUNIZATION AGAINST MEASLES PER THE HEADQUARTERS, DEPARTMENT OF THE ARMY, OFFICE OF THE SURGEON GENERAL, THE EXCLUDED ADULTS MAY RETURN TO THE PROGRAM AFTER THEY HAVE RECEIVED TWO DOSES OF THE MEASLES, MUMPS, RUBELLA

COMBINATION (MMR) VACCINE WITH GREATER THAN OR EQUAL TO 28 DAYS BETWEEN 1ST AND 2ND SHOTS IN SERIES.

3. (U) PROCEDURES:

3.A. (U) UPON DECLARATION OF A MEASLES OUTBREAK, PROGRAM MANAGERS WILL IDENTIFY ALL APPROPRIATED AND NONAPPROPRIATED EMPLOYEES, AS WELL AS FAMILY CHILD CARE PROVIDERS, LOCAL NATIONAL PERSONNEL, SPECIFIED VOLUNTEERS, AND CONTRACTORS WHO HAVE NOT PROVIDED DOCUMENTATION OF IMMUNITY TO MEASLES. THIS WOULD INCLUDE THOSE INDIVIDUALS WHO HAVE APPROVED OR SUBMITTED MEDICAL OR NONMEDICAL EXEMPTION FOR THE MMR VACCINE.

3.B. (U) AT THE DECLARATION OF AN INSTALLATION MEASLES OUTBREAK, ALL NON-IMMUNIZED APPROPRIATED AND NONAPPROPRIATED EMPLOYEES, AS WELL AS FAMILY CHILD CARE PROVIDERS, LOCAL NATIONAL PERSONNEL, SPECIFIED VOLUNTEERS, AND CONTRACTORS, ARE TO BE EXCLUDED FROM THE PROGRAM ACTIVITY UNTIL THE INSTALLATION DEPARTMENT OF PUBLIC HEALTH OFFICE DETERMINES THAT CONDITIONS ALLOW FOR UNIMMUNIZED OR UNDER-IMMUNIZED EMPLOYEES AND STAFF TO RETURN TO THE PROGRAM.

3.C. (U) DATA ON ALL SUSPECTED AND CONFIRMED CASES OF MEASLES WILL BE COLLECTED AND MAINTAINED TO ALLOW REPORTING BY INDIVIDUAL PROGRAMS. PERSONAL INFORMATION WILL BE SECURED AND ACCESS LIMITED IN ACCORDANCE WITH HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT (HIPPA) AND PRIVACY ACT STANDARDS.

3.D. (U) CHILD AND YOUTH SERVICES PROGRAMS WILL SUBMIT TO THE DEPUTY CHIEF OF STAFF, G-9, ANY DATA OR RECORDS ON ALL OUTBREAKS OF MEASLES TO INCLUDE REPORTING OF ALL APPROVED MEDICAL AND NON-MEDICAL IMMUNIZATION WAIVERS AT THE LOCATION.
