1. (U) SITUATION.

1.A. (U) IN LATE FISCAL YEAR (FY) 2023, SELECT ARMY INSTALLATIONS RECEIVED INDEPENDENT REVIEW COMMISSION REPORT ON SEXUAL ASSAULT IN THE

MILITARY (IRC-SAM) FUNDS. THE FUNDS WERE ALLOCATED TO VARIOUS BARRACKS AND BUILDING INITIATIVES, INCLUDING SECURITY UPGRADES. IRC-SAM FUNDS SHOULD BE USED FOR RESEARCH-BASED PREVENTION ACTIVITIES THAT

ARE EVALUATED, "TO ENSURE THAT THE PREVENTION APPROACH DECREASES HARMFUL BEHAVIORS OR ASSOCIATED RISK FACTORS AND IS FEASIBLE FOR THE MILITARY ENVIRONMENT" (REF A, P.18).

1.B. (U) HQDA DCS G-9, DIRECTORATE OF PREVENTION, RESILIENCE, AND READINESS (DPRR) IS PARTNERING WITH DOD OFFICE OF FORCE RESILIENCY, OFFICE OF COMMAND CLIMATE AND WELL-BEING INTEGRATION (OCCWI), WITH CONTRACT SUPPORT FROM NORC AT THE UNIVERSITY OF CHICAGO, ON AN OCCWI-SPONSORED EVALUATION OF THE IMPACT OF BARRACKS SECURITY UPGRADES AND A

COORDINATED COMMUNICATION PLAN ABOUT THE UPGRADES. NORC IS EXECUTING

THE EVALUATION, WHICH IS ONLY OCCURRING WITHIN THE ARMY. SINCE LATE FY23, DPRR AND OCCWI HAVE MET TO PLAN THIS EVALUATION AND ENGAGED WITH

DEPARTMENT OF PUBLIC WORKS AND PREVENTION PERSONNEL AT SELECT ARMY INSTALLATIONS TO IDENTIFY LOCATIONS TO PARTICIPATE. THOSE LOCATIONS ARE FORT BLISS, FORT MOORE, FORT SILL, AND FORT STEWART. FORTS SILL AND STEWART RECEIVED IRC-SAM FUNDS FOR BARRACKS SECURITY UPGRADES. FORTS MOORE AND BLISS DID NOT RECEIVE IRC-SAM FUNDS FOR BARRACKS SECURITY UPGRADES AND WILL PARTICIPATE IN THE EVALUATION AS COMPARISON

LOCATIONS.

1.C. (U) THIS EVALUATION WILL REQUIRE COORDINATION BETWEEN PARTICIPATING INSTALLATIONS, DPRR, AND OCCWI FROM THE RECEIPT OF THIS

ORDER THROUGH FY26. EVALUATION PLANNING WILL CONTINUE UPON RECEIPT OF

THIS ORDER. SUBJECT TO APPROPRIATE APPROVALS, EXECUTION, TO INCLUDE DATA COLLECTION, IS PLANNED TO OCCUR BETWEEN MAY 2025 AND SEPTEMBER 2025. AT ONE INSTALLATION (FORT SILL), OCCWI WILL PROVIDE IMPLEMENTATION SUPPORT FOR A COORDINATED COMMUNICATION STRATEGY ABOUT

THE BARRACKS SECURITY UPGRADES AND IMPLEMENTATION OF THE STRATEGY WILL

BE ASSESSED. AT ALL FOUR INSTALLATIONS (FORTS STEWART, SILL, BLISS, AND MOORE), ~300 E1-E5 SOLDIERS LIVING IN THE NORC PRE SELECTED BARRACKS COMPLETE A VOLUNTARY SURVEY ABOUT THEIR EXPERIENCES AND PERCEPTIONS OF SEXUAL AND NON-SEXUAL CRIME IN THE BARRACKS, FEAR OF SEXUAL AND NONSEXUAL CRIMES IN THE BARRACKS, TRUST IN LEADERSHIP TO KEEP SOLDIERS SAFE IN THE BARRACKS, AND RELATED RISK AND PROTECTIVE FACTORS. AT ALL INSTALLATIONS (FORTS SILL, STEWART, BLISS, AND MOORE), ~10 SOLDIERS AND ~5 INSTALLATION LEADERS COMPLETE VOLUNTARY

1.D. (U) EXECUTION OF SURVEYS AND INTERVIEWS SHALL ONLY PROCEED ONCE

THE ARMY HUMAN PROTECTIONS OFFICE CONCURS WITH DETERMINATIONS MADE BY

THE DOD COMPONENT OFFICE OF HUMAN RESEARCH PROTECTION AND ONCE THE EVALUATION RECEIVES APPROVALS FROM THE OFFICE OF MANAGEMENT AND BUDGET, AS REQUIRED (REF D).

1.E. (U) FURTHER DETAILS TO START EXECUTION OF THIS EVALUATION WILL BE PROVIDED IN FUTURE FRAGMENTARY ORDERS (FRAGOS).

2. (U) MISSION. THE ARMY SUPPORTS PLANNING AND EXECUTION OF THIS EVALUATION TO IMPROVE UNDERSTANDING OF HOW BARRACKS SECURITY UPGRADES

AND COMMUNICATIONS THEREOF IMPACT HARMFUL BEHAVIORS AND RELATED FACTORS.

3. (U) EXECUTION.

3.A. (U) INTENT. THE ARMY GENERATES RIGOROUS EVALUATIONS OF ITS PREVENTION ACTIVITIES AND USES FINDINGS TO INFORM DECISIONS ON PREVENTION STRATEGIES FOR HARMFUL BEHAVIORS.

3.B. (U) CONCEPT OF OPERATIONS. THIS EVALUATION WILL GENERATE INFORMATION ABOUT THE IMPACTS OF A CURRENTLY FUNDED PREVENTION ACTIVITY. IT IS NOT AN INSPECTION. THIS EVALUATION WILL ASSESS BARRACKS SECURITY UPGRADES, WITH OR WITHOUT A COORDINATED COMMUNICATION PLAN, AS A PREVENTION STRATEGY FOR HARMFUL BEHAVIORS. DATA WILL BE GATHERED ON THE OCCURRENCE AND PERCEPTIONS OF SEXUAL AND

NON-SEXUAL CRIME IN THE BARRACKS, TRUST IN LEADERSHIP TO KEEP SOLDIERS SAFE IN THE BARRACKS, AND RELATED RISK AND PROTECTIVE FACTORS. THESE

DATA WILL BE COLLECTED FROM SOLDIERS USING A VOLUNTARY SURVEY COLLECTED AFTER IMPLEMENTATION OF BARRACKS SECURITY UPGRADES AND THE COMMUNICATION PLAN, AS WELL AS USING VOLUNTARY INTERVIEWS CONDUCTED AFTER IMPLEMENTATION. SURVEY DATA COLLECTION IS PLANNED FOR MAY 2025

THROUGH JUNE 2025. INTERVIEW DATA COLLECTION IS PLANNED FOR JULY 2025

THROUGH SEPTEMBER 2025. A TABLE DEPICTING DATA COLLECTIONS AND REQUIREMENTS IS ENCLOSED AS AN ATTACHMENT TO THIS ORDER.

3.B.1. (U) THIS EVALUATION WILL USE A THREE-GROUP DESIGN. GROUP 1 WILL INCLUDE ONE INSTALLATION IMPLEMENTING UPGRADED BARRACKS DOOR LOCKS. GROUP 2 WILL INCLUDE THE SAME BARRACKS DOOR LOCK UPGRADES AS GROUP 1 AND ALSO A COORDINATED COMMUNICATION PLAN TO ANNOUNCE THE UPGRADES TO SOLDIERS. GROUP 3 WILL SERVE AS A COMPARISON CONDITION AND WILL INCLUDE TWO INSTALLATIONS WHO ARE NOT IMPLEMENTING BARRACKS DOOR LOCK UPGRADES OR A COORDINATED COMMUNICATION PLAN.

3.B.2. (U) THIS EVALUATION WILL ANSWER FIVE MAIN QUESTIONS. FIRST, WHAT IS THE IMPACT OF THE BARRACKS SECURITY UPGRADES WITHOUT A COORDINATED COMMUNICATION PLAN (GROUP 1) OR WITH A COORDINATED COMMUNICATION PLAN (GROUP 2) ON THE OCCURRENCE OF SEXUAL AND NON-SEXUAL CRIME IN THE BARRACKS, FEAR OF SEXUAL AND NONSEXUAL CRIMES IN THE BARRACKS, RELATIVE TO A COMPARISON CONDITION (GROUP 3)? SECOND, WHAT IS THE IMPACT OF THE BARRACKS SECURITY UPGRADES WITHOUT A COORDINATED COMMUNICATION PLAN (GROUP 1) OR WITH A COORDINATED

COMMUNICATION PLAN (GROUP 2) ON SOLDERS' PERCEPTION OF LEADER SUPPORT

AND TRUST IN LEADERSHIP TO KEEP THEM SAFE, RELATIVE TO A COMPARISON CONDITION (GROUP 3)? THIRD, TO WHAT EXTENT WERE THE BARRACKS SECURITY

UPGRADES (GROUPS 1 AND 2) AND COORDINATED COMMUNICATION PLAN (GROUP 2)

AND **FIFTH**, WHAT WAS THE RETURN ON INVESTMENT/BENEFIT (E.G., LOWER CRIME AND FEAR OF CRIME) RELATIVE TO THE COSTS IN DOLLARS OF THE INTERVENTION (AS IMPLEMENTED IN GROUPS 1 AND 2)?

3.B.3. (U) SELECT ACOMS SUPPORT PLANNING EFFORTS FOR THIS EVALUATION.

EVALUATION PLANNING AND COORDINATION BETWEEN DPRR/OCCWI AND EACH PARTICIPATING LOCATION WILL BE LED BY AN INSTALLATION REPRESENTATIVE SELECTED BY THE INSTALLATION SENIOR COMMANDER. THE INSTALLATION REPRESENTATIVE WILL BE SELECTED FROM A PREVENTION PROGRAM THAT WORKS CLOSELY WITH THE INSTALLATION'S SENIOR COMMANDER (FOR EXAMPLE, PERSONNEL FROM THE INTEGRATED PREVENTION ADVISORY GROUP, COMMUNITY READINESS AND RESILIENCY INTEGRATORS, OR PERSONNEL FROM THE SEXUAL HARASSMENT/ASSAULT RESPONSE AND PREVENTION PROGRAM).

3.B.4. (U) KEY EVALUATION SUPPORT ACTIVITIES FOR INSTALLATION REPRESENTATIVES ARE ENCLOSED AS AN ATTACHMENT TO THIS ORDER.
